**Alive @ 25 DIVERSION AGREEMENT**

This DIVERSION AGREEMENT is made and effective this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, between the City and the Defendant. Defendant voluntarily accepts the terms and agrees to abide by the conditions of this Agreement, in consideration of which the City agrees to refrain from prosecuting the Defendant upon successful completion of the diversion requirements.

Defendant states as follows:

\_\_\_\_\_ He/she understands that he/she enters this diversion agreement, he/she is entering a plea of guilty.

\_\_\_\_\_ He/she has no other diversions pending in any jurisdiction for the violation stated above.

Defendant agrees to comply with the following general and special conditions of Diversion. Defendant shall:

1. Agree to take the Alive@25 course and provide proof of successful completion.
2. Upon proof of completion the court will suspend costs with the exception of \$65.00.
3. The Defendant will enter into a diversion with a term of 90 days, with the following conditions
  - a. Do not violate the law or ordinance of any city, county, or state.
  - b. Have valid insurance, a valid driver's license, valid vehicle registration and wear a seat belt at all times when operating a motor vehicle.
  - c. Notify the court of any address change, including mailing address.
  - d. Stipulate that service of process shall be deemed sufficient if notice and pleadings are mailed via U.S. Mail, postage pre-paid, first class to said address.

**DEFENDANT'S STIPULATIONS AND WAIVER OF RIGHTS**

I, by signing this Diversion Agreement, waive all of my rights to a speedy trial. I understand and agree that if I violate the terms and conditions of this agreement, the this diversion will be revoked and the Defendant and Parent/Guardian shall be notified to appear for a revocation hearing. Defendant further stipulates that he/she is the proper Defendant and that the charge(s) contained in the complaint occurred in Basehor, Kansas. The City shall run a driving record at the end of the diversion, should a record be found, the City will notify the Defendant and Parent/Guardian of the findings and notice of a revocation hearing to be set within 60 days. Failure to fully disclose or provide truthful information when completing this Diversion Agreement shall be a basis for revocation.
